SMOLT MONITORING FACILITY

Operation:

SMF in bypass mode beginning 6/28 @ approximately 11am. Limited sampling resumes for 6 hours (7am-1pm) every Monday and Thursday since.

JD Fisheries crew continues 24/7 swing shift schedule as required by FPP; it will continue this until the end of sampling season on 9/15.

NO mortalities (0.00%) in the SMF samples by PSMFC since 7/12.

OTHER JOHN DAY ISSUES:

Birds :

see the Avian Numbers tab. We report all species and locations, but in reality only gulls in the tailrace BRZ are relevant at JD.

Record numbers, well over 300 White Pelicans have been estimated at the island downstream of the JD tailrace BRZ ! However, they didn't target the tailrace BRZ until recently (July.) We believe that the WP are currently feeding on the abundant shad and are increasingly entering the JD tailrace BRZ for that reason.

USADA avian hazing ended on July 30th

The following avian lines have snapped this season and are out of commission; 44, 46, 56, and 60. Line 55 snapped 7/17 bringing the total snapped lines to 7 (lines 25 and 26 have been out of commission since 2013) 118 lines remain. Planning to replace in September/October

Operations:

JD North Fishway in regular service; 5 out of 6 AWS pumps are available. Repair work on pump 4 continues; pump 3 has vibration issues and should be the last last in service.

JD South Fishway in regular service with 3 AWS Turbines; it is meeting the optimal FPP criteria.

Unable to complete the August STS inspection due to failed camera device.

MU Gatewell Drawdowns: Differentials are checked Wednesdays and Sundays; all gatewells were in criteria.

Maintenance:

Underwater STS camera device failed on 8/19 ; it is being repaired by JD Electrical.

JD North AWS pumps: four out of total six are available. Repair of AWS pump # 4 by a contractor started on 1/26 & is ongoing.

Calibration: All gauges/ sensors are within the criteria of 0.3' .

Research:

2015 Adult Fish Counting by Normandeau Associates commenced on 1 April, 2015 and will continue daily through 1 November.

Lamprey trapping and collection of adults & juveniles for various tribal and non-tribal studies complete for the 2015 season.

Dam angling to remove NPM from JD PH tailrace, by a crew from Washington F&W underway. 2,801 season total as of 8/9/15.

Proposal by PSMFC to install Adult PIT antennas at both JD Fishways is pending; possible installation during the next winter maintenance season 2015/16.




